(2) the plumbing will be inspected prior to covering with insulation, drywall, etc., and again upon completion of the system prior to occupancy. (3) all plumbing work will be done in accordance with the Rio Grande County Plumbing Code as amended and adopted by the Rio Grande County Board of County Commissioners.
