RESOLUTION NO. 2020- 14

**THE BOARD OF COUNTY COMMISSIONERS SHALL SIT AS THE BOARD OF
SOCIAL SERVICES FOR RIO GRANDE COUNTY AND THE BOARD OF HEALTH
FOR THE RIO GRANDE COUNTY PUBLIC HEALTH AGENCY**

WHEREAS, C.R.S. §30-10-303 requires that each board of county commissioners meet at least one business day each month and at such other times within the county as in the opinion of the board the public interest may require; and

WHEREAS, C.R.S. §26-1-116(1) provides that the county board of social services shall consist of the board of county commissioners for each county; and

WHEREAS, the Board of County Commissioners for Rio Grande County established the Rio Grande County Public Health Agency in accordance with C.R.S. §25-1-506 on April 1, 2009, by way of Resolution No. 2009-06, and in so doing, also appointed the Board of County Commissioners to serve as the county board of health pursuant to C.R.S. 25-1-508, *et. seq.*; and

WHEREAS, the Board of County Commissioners for Rio Grande County, Colorado, (“the Board”) believes that authorizing the Board to sit simultaneously as the Board of Social Services and the County Board of Health, without having to first adjourn and reconvene as a separate board, will provide a more practical, expeditious means for conducting meetings and conserving the resources of the County.


NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS FOR RIO GRANDE COUNTY, STATE OF COLORADO:

THAT, whenever a meeting of the Board of County Commissioners for Rio Grande County is convened, the Board shall simultaneously sit as the Board of Social Services for Rio Grande County and as the Board of Health for the Rio Grande County Public Health Agency.


